

## 2015 IOSCO ANNUAL MEETING REGULATORY WORKSHOPS Tuesday, 16 June 2015 – London

## WORKSHOP I (10:00-12:30) CREDIBLE DETERRENCE

Misconduct in financial markets has profound and far-reaching consequences for all levels of society. Enforcement plays a central role in deterring misconduct – this requires regulators to consider and review their enforcement strategies and the effectiveness of those strategies.

Credible deterrence is a key component of any effective enforcement strategy. This workshop will discuss credible deterrence and the key factors of an effective credible deterrence enforcement strategy. This workshop will consider how these key factors can help regulators decide what credible deterrence means for them in the context of their strategic objectives, powers and responsibilities, and their local economic, financial and market context. This will provide a useful insight to those engaging in designing, developing, reviewing or reconsidering their enforcement strategies. This workshop will raise awareness of global enforcement practices that seek to deter misconduct in securities and investment markets, including real life examples of credible deterrence in action from IOSCO members' experiences.

The workshop will feature a presentation of the IOSCO Committee 4 Credible Deterrence Report followed by a panel discussion.
