Based on the foregoing, the Securities Commission stresses that investors wishing to invest in foreign stock exchanges must verify that the companies they deal with are licensed by the Securities Commission by following the link of companies licensed to deal in foreign stock exchanges below.

Accordingly, we inform you of the need to take all necessary precautions and measures to deal with the above-mentioned counterfeiting process when dealing with any client.

- The **JSC** calls on licensed companies to inform investors of the risks of dealing in foreign currencies and that the profit is uncertain.
